Murex Petroleum Corporation (“MPC”) has launched a direct deposit payment program service to all of our interest owners residing within the United States. This program will ensure that automatic monthly payments are made to your banking institution. If you wish to receive revenue payments by direct deposit, please complete and return the enclosed direct deposit enrollment form along with a copy of your voided check. Be advised that after enrollment, your first direct deposit will be sent into your bank account on or about the 20th of each month, dependent upon holidays or weekends. To change bank accounts for this service you must complete a new direct deposit form along with a W9 form. In order to cancel this payment method, please provide us notification in writing.

Once your direct deposit begins, you will not receive a paper check. Murex has partnered with EnergyLink to allow owners greater flexibility in obtaining revenue data. Your check detail will be available via EnergyLink and you may access your check detail by setting up an account at www.murexpetroleum.com. Click on Owner Relations>Royalty/Mineral Owners and follow the instructions or call EnergyLink at 1-888-573-3364 to obtain a unique user name and password. Please use this number for all other login inquiries as well. Murex will not be able to assist you with this process.

All new owners must complete and return a W9 form in order to set up an account for payment. You will receive a paper check unless you choose to complete the attached direct deposit enrollment application. Note: An updated W9 form is required for any address changes.

If you are an interest owner with more than one Murex account, you are welcome to complete the direct deposit information for each account that you may have with MPC.
